Art, crafts, handmade goods, antiques, vintage stuff, collectibles, packaged food and basement treasures are welcome!

The Lucky Squirrel is now one of the largest flea market, craft and vendor shows in the area. In order to keep our shoppers happy and engaged, we do our best to bring in new vendors who have not done our show in the past. Due to the continued growth, vendor registrations will be accepted on a first come, first paid basis, subject to approval. Please note, acceptance in past events does not automatically guarantee that you will be accepted this season.

VENDOR DATES: This year the Lucky Squirrel will be held **rain or shine** on the third Saturday May - September. May 18, June 15, July 20, August 17, and September 21. 10 am to 3pm.

LOCATION: This is an *outdoor* event located in the Garden City Town Center Shopping Plaza at the northeast corner of Ford Rd & Middle Belt Rd.

VENDOR FEES: Vendor fee for each 10 x 10 space is \$15.00. Multiple spaces are available for an additional \$15.00 per space.

ASSIGNED SPACES: Vendor spots will be assigned on a first come, first served basis. To guarantee your spot next to another vendor, both vendor apps need to be turned in together. Canopy tents are allowed however, they must be securely weighted down on all four sides. No holes are allowed in the pavement.

NOT INCLUDED: Unfortunately, we do not provide tables, chairs, tents, electricity or internet access.

FOOD VENDORS: Food vendors need to submit an itemized list with prices, copy of your food license and will be subject to approval. NO gas generators, electric only. Food Vendors may have access to electricity for an up charge of \$10.00 on a first come, first available limited basis.

DEADLINE & PAYMENT: To secure your space, full payment is expected with signed registration forms by the 1st day of the event month, however to guarantee you spot for multiple dates, please plan to pay for all dates in full by May 1st. Space is limited and may sell out so don't wait. Cash or check payable to GC DDA. We do not accept credit cards payments.

NO REFUNDS OR TRANSFERS ALLOWED: This event is rain or shine. There will be **NO REFUNDS** for cancellations or in the case of inclement weather. Vendor fees are not transferable to other vendors or other vendor dates. Vendors are responsible for any NSF fees.

VENDOR EXPECTATIONS: Vendors are expected to arrive at their assigned time, unload quickly, be courteous of other vendors, park in designated vendor area **before** setting up. Once parked, vendors may then set up. Vendors are asked to be ready to sell on time, secure property, display wares until the event is over, clean up and dispose of all personal trash.

PROMOTE! Vendors are asked to help promote the event via word of mouth, social medial, flyers, Craig's list etc. Flyers are available in the DDA Office.

NOT ALLOWED: Vendors are not allowed to bring pets. Weapons, pornography, alcohol, drug or drug related paraphernalia is prohibited. No smoking except in designated picnic area.

Failure to comply with the above will result in being asked to leave and/or not being asked to return to future city events.

GC DDA EXPECTATIONS: The DDA will send a confirmation email within 10 days of receiving payment, email a map 10 days before the event date, provide a 10X10 vendor space, promote the Lucky Squirrel via local advertising, posters in local establishments, posting to social media, and signage throughout the community.

Vendors are expected to be courteous, unload quickly, then park in the designated area for vendors before setting up.

Vendors must be set up on time, secure property, display wares until event is over, clean up and dispose of all personal trash.

Vendors are not allowed to bring pets. Contraband and dangerous objects are also prohibited.

No smoking except in designated picnic area.

NO REFUNDS - Vendor fees are non-transferable and non-refundable, including in the event of severe weather. Vendors will be responsible for NSF fees.

Please note, acceptance in past events does not automatically guarantee that you will be accepted this season.
